- 1. The *Government of Ghana* has received financing from the World Bank toward the cost of *the West Africa Food System Resilience Project (FSRP)* and intends to apply part of the proceeds toward payments under the contract for *Design-Build, Supply, and Installation of Equipment for the Rehabilitation of Selected Border Posts*
- 2. The *Ministry of Food and Agriculture (MoFA)* now invites sealed Bids from eligible Bidders for the *Rehabilitation and Equipping of four (4) Selected Border Posts under a Design-Build*. The objective of this assignment is to obtain the services of a Firm to assess the state of infrastructure and facilities at the identified border posts, conduct engineering/ architectural studies, produce designs, and drawings and subsequently rehabilitate or construct and equip the approved **border post facilities** ("the Facilities").

The selected border post sites are indicated in the table below.

Applicants are to take note that, the Assignment will be conducted in two parts, namely:

Part 1 — **Design Requirement** - Site Assessment, Determination of Scope of Works per each site, Preliminary Architectural/Engineering Designs, Detailed Architectural/Engineering Designs (the preparation of architectural plans and layouts), Costing, and Preparation of sustainability plan. The service provider will also provide a list of office furniture, fixtures and equipment required for operationalizing the posts.

Part 2 – Construction and Installation Works covering the construction period & Post Construction Defects Notification Period (DNP).

Bidding will be conducted through national competitive procurement using Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers [Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers published in September 2023, 5th edition] ("Procurement Regulations"), and is open to all eligible Bidders as defined in the Procurement Regulations.
- 4. Interested eligible bidders may obtain further information from *MoFA* (*FSRP Procurement Specialist*) and inspect the bidding document during office hours from 0900 to 1700 hours at the address given below
- 5. The bidding document in the *English Language* may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of *USD100 or GHS1,600.00*. The method of payment will be *Cash payment*. The document will be physically picked at the address below.
- 6. Bids must be delivered to the address below on or before 10:00 am GMT on December 12, 2024. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below in the FSRP's Conference Room at 10:30 am GMT on December 12, 2024.

- 7. All Bids must be accompanied by a **Bid Security** of **Five Hundred Thousand Cedis** $(GH \not\in 500,000)$.
